"The purpose of this study was to determine the effects literature circles have on students'

perspective toward reading. The literature suggested that literature circles are used to motivate students to read, enhance learning, and increase reading level. This study was conducted in a fifth grade classroom. Four students, two boys and two girls, exhibiting a lack of motivation toward reading participated in this study. All students were English Language Learners (ELL), three of them were of Latino descent and one was Filipino. Data was collected on the four participants through various means including observations, journal entries, surveys, AR quiz scores, STAR reading test scores, fluency results, reading comprehension test results, and a final reflection. This study was performed during a three-month period. The participants read four books during this time and met daily to discuss the literature. The findings showed that students gained a positive perspective toward reading, became motivated, took the initiative to read on their own, and improved in reading comprehension and reading ability as a result of participating in literature circles."--From

In 1966 the first meeting of the Association for the Study of Attention and Performance was held in the Netherlands to promote the emerging science of cognitive psychology. Enduring poverty, hunger, fear, abuse, and hatred while growing up in the woods of Mississippi, Wright lied, stole, and raged at those around him—whites indifferent, pitying, or cruel and Blacks resentful of anyone trying to rise above their circumstances. Desperate for a different way of life, he headed north, eventually arriving in Chicago, where he forged a new path and began his career as a writer. At the end of *Black Boy*, Wright sits poised with pencil in hand, determined to "hurl words into this darkness and wait for an echo." Seventy-five years later, his words continue to reverberate. "To read *Black Boy* is to stare into the heart of darkness," John Edgar Wideman writes in his foreword. "Not the dark heart Conrad searched for in Congo jungles but the beating heart I bear." One of the great American memoirs, Wright's account is a poignant record of struggle and endurance—a seminal literary work that

illuminates our own time.

The United States Social Security Administration (SSA) administers two disability programs: Social Security Disability Insurance (SSDI), for disabled individuals, and their dependent family members, who have worked and contributed to the Social Security trust funds, and Supplemental Security Income (SSI), which is a means-tested program based on income and financial assets for adults aged 65 years or older and disabled adults and children. Both

programs require that claimants have a disability and meet specific medical criteria in order to qualify for benefits. SSA establishes the presence of a medically-determined impairment in individuals with mental disorders other than intellectual disability through the use of standard diagnostic criteria, which include symptoms and signs. These impairments are established largely on reports of signs and symptoms of impairment and functional limitation. Psychological Testing in the Service of Disability Determination considers the use of psychological tests in evaluating disability claims submitted to the SSA. This report critically reviews selected psychological tests, including symptom validity tests, that could contribute to SSA disability determinations. The report discusses the possible uses of such tests and their contribution to disability determinations.
